
BMO Premium Yield ETF Fund



About the fund

The portfolio will invest in a concentrated basket of 40-50 large-cap U.S. equities. Stocks are selected based on quality fundamentals such as strong balance sheets, low debt to equity, high return on equity and liquidity screens. In normal market conditions, the fund will target a range of 25–50% to be invested in equity securities.



The portfolio ranges referenced are what the portfolio aims for in normal market conditions. The portfolio composition can change based on market movements. As market conditions change, the portfolio's equity and option exposure may vary. The asset mix illustrated below is a target under normal market conditions.
