The Multi-Asset Solutions Team (MAST) works to achieve the right balance between managing risks and seizing opportunities to deliver outcomes clients are seeking.

#### A Top-Down Approach

MAST follows a disciplined investment philosophy, beginning with a 1,000-foot view of strategic asset allocation. From a bird's vantage point, each asset class can be weighed not only for returns and risk, but also their correlation to other investment areas in the portfolio. How the pieces fit together is of primary concern. It determines the baseline asset mix from which the team can build multiple risk-weighted portfolios. MAST aims to offer every investor a solution that provides the highest expected return in relation to their risk tolerance level.

However, there are times when the team's short-term outlooks differ substantially from the bird's eye view. In these cases, tactical asset allocation is employed at the 'ground level' — deciding where to be more or less bullish, the need to adjust geographic weightings (both within equities and bonds) and whether to have more or less of a certain exposure (i.e., government vs. corporate

bonds). Afterwards, adjustments are made to certain styles or factors. Concluding the process, the team implements tactical changes via a scorecard and communicates the updates through the Five Lenses.
